**COURSES, BIRDS & OTHER INFORMATION:**

Silo Course 1 - single course without bird field & may be run as an alternating course in and out without bird field. Silo Course 2 is a single course without a bird field.

Quail used in all stakes.

Open Gun Dog is a retrieving stake with callback for retrieve.

A blank cartridge will **NOT** be fired in Open Puppy

Shotguns with blank shells will NOT be permitted.

Horseback handling will NOT be permitted in any stake.

Tracking collars permitted per AKC rules and regulations, and are permitted in the callback for retrieve.

Orange vests are mandatory for judges, handlers, marshals, gunners and bird planters during callback for retrieve.

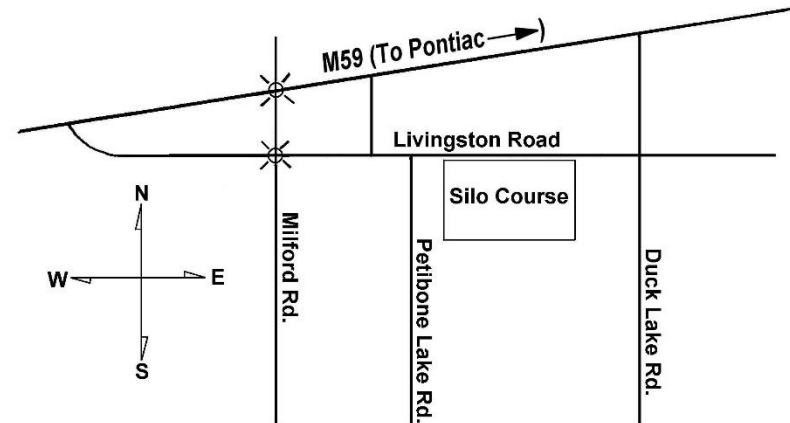
