**COURSE & BIRDS:** All Levels will be run on a Single Course with a Bird field. Quail and/or Chukar will be released in all levels.

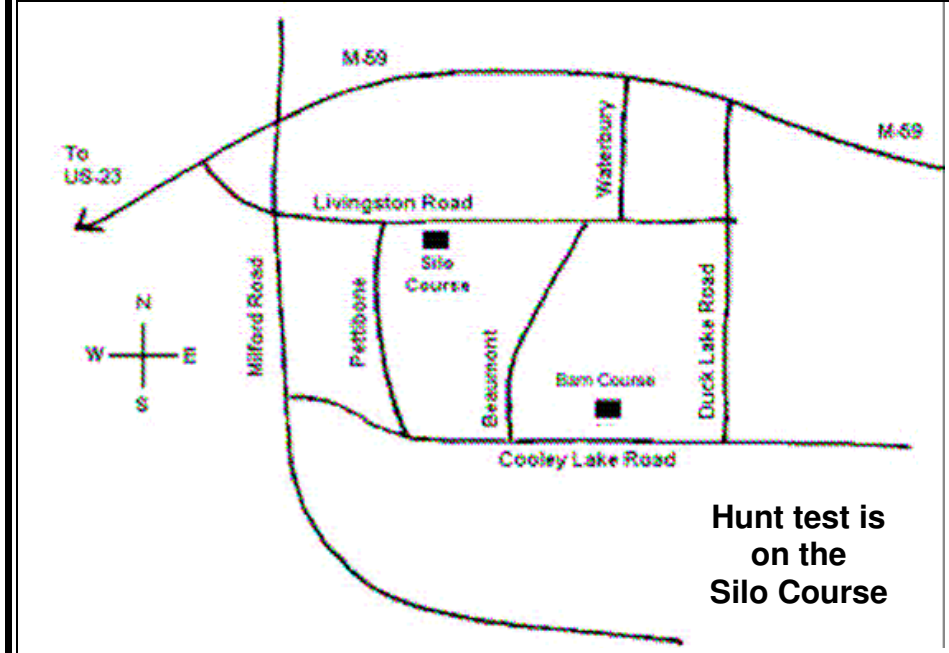
