A blank cartridge will **NOT** be fired in Open Puppy

Shotguns with blank shells will NOT be permitted.

Horseback handling will NOT be permitted in any stake.

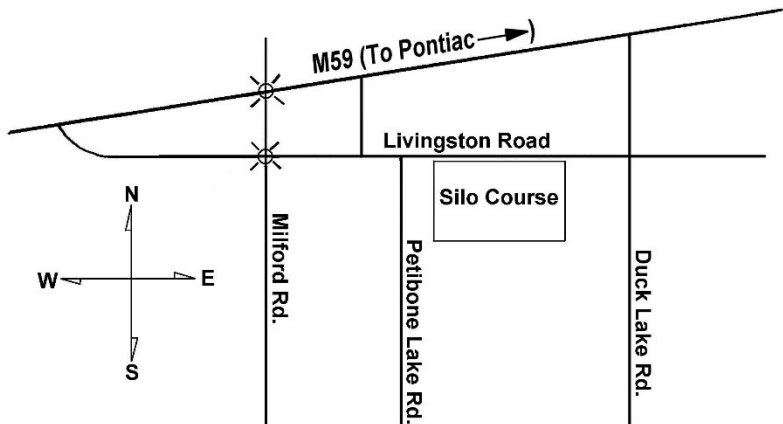
Tracking collars permitted per AKC rules and regulations, and

<p><b>PARKING</b></p>	<p>A Michigan Motor Vehicle State Park permit is required to park on the grounds. Cost is \$9.00 per day or \$32.00 for an annual permit for Michigan residents, and slightly higher for non-residents.</p>
<p><b>CAMPING</b></p>	<p>Camping is permitted on the Field Trial Grounds. A Camping fee of \$12 per night is to be paid to the trial secretary before leaving the event. A \$20 additional fee will be accessed by club if camping is not paid for prior to parties leaving grounds</p>
