Shotguns with blank shells will NOT be permitted.

Horseback handling will NOT be permitted in any stake.

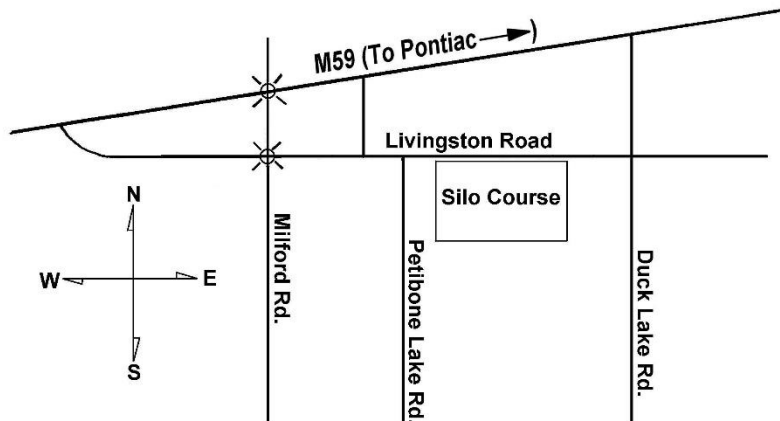
Tracking collars permitted per AKC rules and regulations, and
