COURSE & BIRDS: All Levels will be run on a Single Course with a Bird field. Quail and/or Chukar, Pheasant will be released in all levels.

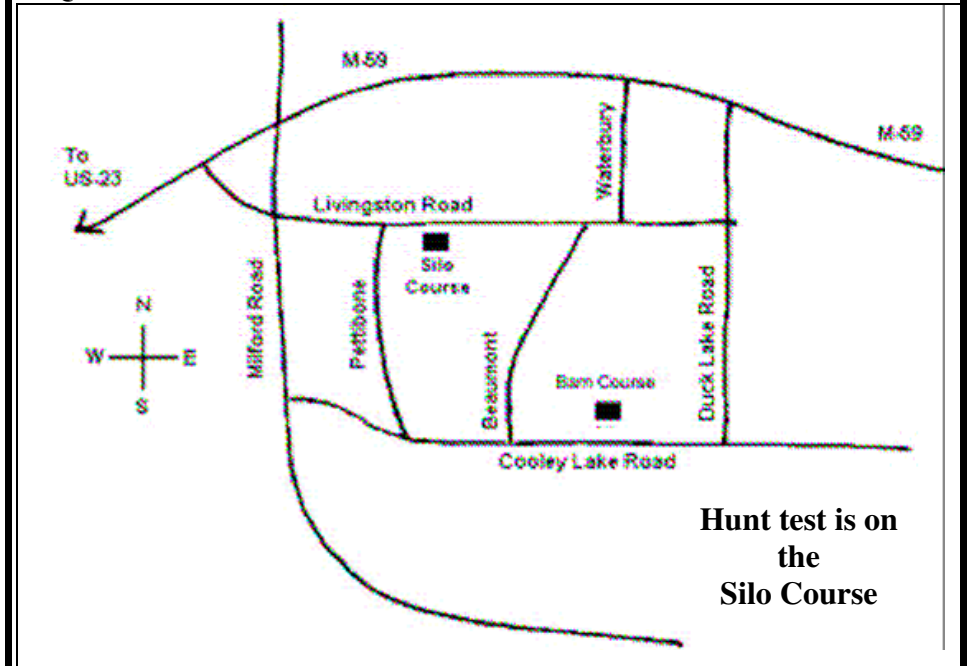
