**COURSES, BIRDS & OTHER INFORMATION:**

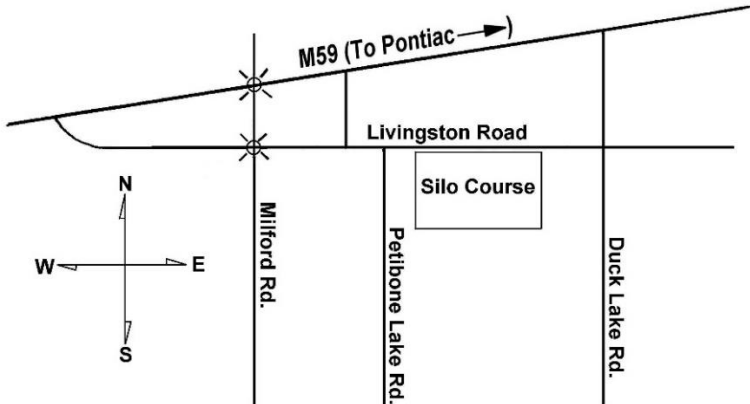
Quail and/or Chukar, Pheasant used in all stakes.

A blank cartridge will **NOT** be fired in Open Puppy  
Shotguns with blank shells will NOT be permitted.  
Horseback handling will NOT be permitted in any stake.  
Tracking collars permitted per AKC rules and regulations, and

are permitted in the callback for retrieve.  
 Orange vests are mandatory for judges, handlers, marshals, gunners and bird planters & spectators during callback for retrieve.
